

# ROBINSON PARKING INFORMATION GUIDELINES AND REGULATIONS

## FOR 2024-25 (please sign on second page)

You are requesting the privilege to park on school property during the school day. At this time, only seniors will be allowed to apply for a parking space for the 2024-2025 school year. The school shall determine the justification for student use of private automobiles on school grounds. Only students with a valid driver's license will be considered. The maximum number of spaces to be sold is 400. Seniors can purchase a parking permit beginning August 15<sup>th</sup>.

#### **Robinson Parking Facts**

Parking is a Senior Privilege. Seniors must meet the deadline for submitting appropriate forms in order to receive a parking permit. Fairfax County Public Schools School Board Policy sets the mandatory \$200 fee for parking passes.

# FAIRFAX COUNTY PARKING PERMITS & FEES ARE NON-REFUNDABLE and NON-TRANSFERABLE General Regulations

- Maximum speed limit on school grounds is 15 mph at all times.
- Passengers may only be dropped off in designated areas near entrance #1 and #7.
- Illegal U-Turns on the back access road will result in suspension and/or revocation of a student's parking permit.
- Parking on school grounds is a privilege and with it comes certain obligations and responsibilities. All students must drive responsibly and obey the laws of the Commonwealth of Virginia and the Fairfax County Code, including "passenger restriction laws."
- All drivers must be properly licensed and vehicles must be properly registered and inspected
  in accordance with state and county laws. Vehicles must also be registered with the school.
  Students must park in authorized areas only and must have their parking pass properly
  displayed at all times.
- Students are not permitted to back into parking spaces.
- Parking unauthorized vehicles may result in citations, booting and towing.
- Vehicles are off-limits to students during the school day (8 am to 2:45 pm). Students may not leave school grounds or go to their vehicles during the school day without proper authorization.
- Parking passes and campus driving privileges may be revoked at the discretion of school administration. Students may lose their parking privileges should they transfer, sell or lend their parking pass to a third party.

• In addition to the security staff, the Fairfax County Police Department's Parking Enforcement Unit regularly patrols the parking lots of Robinson Secondary School. If a student, visitor or staff member receives a parking summons from one of these officers, they must contact the police department or courts for further information. The Robinson Security Office cannot intervene in any matter regarding police department issued summonses.

### **Consequences of Violating Parking Regulations**

Consequences will be assigned by your Sub-School Administrator.

Consequences may include some or any of the following: fines (\$50), vehicles being booted (\$50), suspensions and/or revocation of your parking permit. Your school record including student behavior and attendance can affect your parking privileges.

Fines must be paid within 14 days from the date on the ticket. Failure to do so may result in loss of parking privileges or administrative sanctions.

#### SENIOR PARKING

Seniors with permits may park in designated areas marked in GOLD on the map online at Robinson SS. Parking in any other area will result in fines (\$50), vehicles being booted (\$50), suspensions and/or revocation of your parking permit.

There is no parking on a yellow curb or in Reserved or Visitor Parking.

#### **UNDERCLASSMEN PARKING**

If spaces allow, underclassmen may be able to purchase a parking permit. Underclassmen with permits may park in designated areas marked in BLUE on the map online at Robinson SS. Parking in any other area will result in fines (\$50), vehicles being booted (\$50), suspensions and/or revocation of your parking permit.
